Information on Breeding

- All booking fees are due when you send in your signed contract. If you want a discounted breeding make sure to get your contract and fees in by the deadlines. All booking fees are made payable to: Dream Street Stallions or Rick Rockefeller-Silvia
- We require our mare owners to supply a credit card number for shipping and handling expenses. You are welcome to supply a Fed Ex account number to cover the shipping portion of your bill. This way no deposit is required. We will however, charge a fee of \$25.00 per day fee for tardy container returns. You have 5 business days to return the container to us.
- Our stallion collection fee is \$180. Per collection. The vet clinic (Palm Beach Equine) will bill you separately for collections.
- Your breeding certificate/report will arrive in your first shipment. Please make sure that you and your vet follow the instructions, this is an important document and you will need to retain the ORIGINAL for your records and future registration of the foal.
- Shipment orders must be received no later than 4:30 PM EST the day before shipment for overnight delivery and for airport shipments. Please do NOT order days/weeks in advance unless you're purchasing frozen semen.
- OUR BREEDING SHED CLOSSES SEPTEMBER 1ST. We will only be able to supply frozen semen after this date.
- We do not ship or collect on Saturdays or Sundays and on some very rare weekdays if we have to leave for a long show. We do ship 3 days a week including Monday, Wednesday and Friday -the shipments are good throughout the weekend, so do try to foresee if you'll need a weekend shipment and check with our show schedule.

Frozen Semen Information

- Palm Beach Equine will charge a \$150.00 container rental fee, \$75.00 handling fee, in addition to shipping expenses.
- Our frozen semen was collected impart by the New Bolton Center and Palm Beach Equine.
- Two breeding doses= One Breeding. Four to five straws= One dose.
- We require that all empty/used straws be returned via mail to Dream Street Stallions for cataloging, prior to any additional semen being shipped (LFG).
- Your semen will arrive to you via overnight shipment in a Cryodrum.

- If you have any questions, please do not hesitate to give us a call we will try to help you any way that we can.
- We require 24 hours notice before frozen semen can be shipped.
- A complete semen evaluation sheet as well as thawing instructions will arrive with the semen.

TERMS AND CONDITIONS

1. Fresh Semen-

The mare owner shall pay a non-refundable booking and breeding fee of **\$2500.00** The booking & breeding fee are due to Dream Street Stallions Inc. upon the execution of this contract.

The mare owner shall pay a non-refundable lab/shipping fee of **\$*180.** (paid directly to Palm Beach Equine Clinic, via credit card) (***\$130.00** , for an overnight shipment. ***\$150.00** , for a Friday to Saturday shipment; (paid directly to Palm Beach Equine) ***\$255.00** from airport (Palm Beach International). These fees will be billed to you directly by our vet's office. A credit card is required for the collection fee. **\$20 discount per pickup/collection will be given** if you pick up at Dream Street Stallions and pay via cash or check at time of pick up.

Prices for collections subject to change without notice, due to changing fuel costs/price, supply costs and shipping charges.

2. Frozen Semen-

The Mare owner shall pay a non-refundable frozen breeding fee of **\$1200.00** Payable to Dream Street Stallions Inc. or Richard L Rockefeller-Silvia, before the semen is sent or released to the mare owner.

The mare owner will supply a credit card number directly to Palm Beach Equine, in which will bill the mare owner directly for **\$150.00** frozen container rental, **\$75.00** handling fee and **\$120.00 - \$175.00 (Fed Ex)** over night shipping expenses incurred.

3. (LFG) The mare owner shall be entitled to re-breed the mare until the mare delivers a foal that stands and nurses. This guarantee shall apply only if the mare owner notifies DSS either in writing or via E-mail,

of any problems pertaining to this breeding. **IF DREAM STREET STALLIONS INC. IS NOT NOTIFIED IN WRITING, AS INSTRUCTED, ALL GUARANTEES, BREEDINGS, OR REGISTRATION POSSIBILITIES ARE NULL AND VOID.**

. **The breeding report/certificate will come packaged with the first semen shipment of the breeding year, please make sure to have your vet fill out the form. Your vet will also need to verify on the certificate that the mare was cultured prior to breeding. PLEASE NOTE: LFG for frozen semen only cover up to 4 separate shipments of frozen semen!**

4. If a licensed veterinarian determines that the mare is unsuitable for breeding, the mare owner may substitute a new mare, subject to acceptance by Dream Street Stallions. This substitute mare shall be bred under the same terms and conditions as the original mare. (Please fax in the new mares information)

5. In the event of breeding by transported semen, mare owner shall give Dream Street Stallions **advance notice of request for shipment no later than 4:30 PM the day before shipment** Mare owner shall pay, in addition to the booking and breeding fees, all reasonable and actual costs of transporting the semen from Dream Street Stallions to mare owner, as well as insemination of the mare by mare owner's veterinarian and the expense of returning the container to Palm Beach Equine Hospital or our contracted frozen semen distributor.

6. In the event of breeding by frozen semen, mare owner shall give Dream Street Stallions advance notice no less than **two business days**. In the event of an additional shipment of frozen semen, per our LFG, the mare owner shall first be required to return the original straws shipped (empty).

7. Dream Street assumes responsibility only to deliver live semen in viable condition at the time of delivery to the mare owner or agent. For frozen semen the PTM must be higher than 30% only. The mare owner shall assume all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whatsoever by death, disease, injury, infection or otherwise, and by any cause whatsoever, including inappropriate, untimely, or negligent insemination or failure of insemination, and therefore releases, discharges, indemnifies and holds harmless Dream Street Stallions/stallion owner, its employees, agents, officers and directors, from any liability for any and all damages associated therewith. The mare owner hereby agrees to pay all expenses and attorney's fees incurred by Dream Street Stallions/stallion owner in defending any claims for which the mare owner has agreed to release, discharge, indemnify and hold harmless Dream Street Stallions/stallion owner, its agents, employees, officers and directors.

8. The mare owner agrees to use the shipped semen **only** on the mare named above in this contract and shall have a licensed veterinarian verify in writing that the shipped semen has been used only to inseminate the mare named above in this contract. The mare owner agrees to deliver such certification to Dream Street Stallions within the breed report at the end of the breeding season. Breeding any mare other than the named mare on this contract, with semen supplied by Dream Street Stallions, will result in legal action.

9. If the above described Dream Street stallion is not available to Dream Street Stallions for re-breeding, and if re-breeding is necessary, Dream Street Stallions may, at its option, and mare owner's approval, substitute another stallion for breeding to the mare. Dream Street Stallions is not liable for refunds, re-breeding, or any other claims for stallions standing at Dream Street Stallions. Dream Street Stallions **may elect to substitute frozen semen at anytime, in place of fresh semen**

10. The live foal guarantee mentioned in paragraph 4 above is expressly contingent upon the mare owner properly caring for the pregnant mare. Proper care shall include, but shall not necessarily be limited to,

proper feeding and nutrition, regular de worming with products approved for pregnant mares, vaccinations that are customary in the mare owners geographical area, and proper intervention during foaling if necessary.

11. The contract's time table goes into effect during the breeding season calendar year. Unless you are working with frozen semen, that is purchased prior to the breeding season in which you intend to begin using it. If the mare is not covered, bred or delivers a live foal within 2 (two) breeding seasons, starting from February 1st and ending September 1st of the first breeding season following or during the year contract was signed (breeding seasons are February 1st - September 1st), the contract will be null and void and no refunds, rebreedings, or fees will be returned/given to Mare owner. The non refundable booking fee is recharged if this contract is carried into a third breeding season, This will renew the contract for one (1) additional breeding season.

12. The mare owner may not assign any rights or delegate any duties under this contract without the prior written consent of Richard L. Rockefeller-Silvia/stallion owner.

13. No delay or failure by Dream Street Stallions/stallion owner to exercise any right under this contract shall be deemed a waiver of any right or remedy otherwise available to Dream Street Stallions LLC.

14. This contract contains the entire understanding of the parties and may be modified only by a writing signed by all parties. The invalidity or unenforceability of any term or provision of this contract shall not affect the validity or enforceability of any remaining provisions hereunder. This contract shall be construed and governed by the laws of the State Of Florida, and the parties expressly agree the jurisdiction and venue for any and all disputes arising under this contract shall be proper only in Palm Beach County, Florida. In the event that Dream Street/stallion owner incurs attorney's fees and/or legal costs in securing or protecting any right available to it under this contract or under the laws of the State of Florida, the customer agrees to pay said attorney's fees and costs.
